

**THE CORPORATION OF THE
MUNICIPALITY OF MORRIS-TURNBERRY**

BY-LAW NO. 26-2010

**Being a by-law to authorize the Municipality of Morris-Turnberry to execute and
affix the Corporate Seal to amend Schedule 'G' of the agreement for Fire
Suppression Services with the Township of North Huron**

WHEREAS, Section 8 of the Municipal Act, 2001 S.O. 2001 c. 25 as amended, states that;
'Powers of a natural person – A Municipality has the capacity, rights, powers and privileges of a
natural person for the purpose of exercising its authority under this or any other Act';

AND WHEREAS the Fire Protection and Prevention Act, 1997, S.O. 1997, c4, authorizes a
municipality to provide and/or receive fire protection services to or from other municipalities;

AND WHEREAS, the Council of the Municipality of Morris-Turnberry deems it necessary and
desirable to amend the Schedule 'G' of the Fire Suppression agreement with the Township of
North Huron, as approved by By-law No. 76-2009;


AND WHEREAS, the amended 'Schedule 'G' is attached hereto and forms part of this By-law
as Schedule 'A';

AND WHEREAS, the Corporation of the Municipality of Morris-Turnberry **enacts as follows:**

1. That the Mayor and Clerk of the Municipality of Morris-Turnberry are hereby authorized
to execute and affix the Corporate Seal to the By-law to authorize the Municipality of
Morris-Turnberry to amend Schedule 'G' of the Agreement for fire suppression service
with the Township of North Huron.
2. That this By-law comes into force on the date of the final passing thereof.

SCHEDULE "G" – FIRE COVERAGE BETWEEN JANUARY 1, 2010 AND April 7, 2010.

This is Schedule "G" to a Municipal Fire Protection Agreement dated January 1, 2010 between the Corporation of the Township of North Huron and the Corporation of the Municipality of Morris-Turnberry.
